DUI PROGRAM

As you are aware, you have been charged with a Driving Under the Influence Offense. According to House Bill 2533, a CRN (Court Reporting Network) evaluation must be completed on all individuals charged with this specific violation of the law. A drug and alcohol evaluation may also be required based on your blood alcohol level. This evaluation must be scheduled within 5 days after your Preliminary Hearing.

The cost of the CRN Evaluation is \$70.00, and the cost of the drug/alcohol evaluation is \$175.00. If you need to complete both evaluations, you must bring \$245.00 at the time of your appointment. Cash, Money Orders, VISA / MasterCard or Personal Checks are accepted. Checks should be made out to Court Financial Services (CFS).

GUIDELINES

An additional cost of \$50.00 will be assessed for each "missed appointment." Therefore, it is important that you show for you appointment.

It will also be necessary that you bring proof of your BAC (Blood Alcohol Content). Without a BAC, your evaluation will not be complete and will not be sent to PENNDOT.

It is VITAL that you attend this scheduled evaluation appointment in order to comply with your court requirements. The courts will be informed of any failure to attend this appointment.

No one will be seen for their appointment if there is a presence of drugs or alcohol in their system. If a person appears for a CRN evaluation and is under the influence of alcohol or drugs, it is the obligation of the DUJ staff to take all measures to ensure the safety of the client and others and also to evaluate for a possible referral to an inpatient treatment program. Also, please be aware that the court will be informed if a person appears for the CRN evaluation under the influence.

DIRECTIONS TO COURT FINANCIAL SERVICES (CFS) OFFICE:

1. GO UP THE STAIRS TO DOOR "R", FIRST FLOOR, TURN LEFT
2. ON LEFT, GO THROUGH THE HALL OF JUDGES' PICTURES, AT THE END MAKE A RIGHT, GO DOWN HALL PAST JURY LOUNGE TO ELEVATOR AT END
3. GO TO "B" (CAFETERIA / BASEMENT), TURN RIGHT AND FOLLOW HALL, YOU WILL PASS THE CAFETERIA
4. YOU WILL COME OUT IN THE MIDDLE OF THE GOVERNMENT CENTER BUILDING (ON LEFT- PARK POLICE, MIDDLE OF THE ROOM-STAIRS)
5. TURN RIGHT, GO PAST THE ELEVATORS, FIRST OFFICE ON THE RIGHT
